The Bay Garden Centre has donated two trees to the 'Plant a million trees' Woodland Trust initiative. The resident that attended the meeting will organise a free raffle for parishioners to win a tree to plant. The school has been contacted to see if they will be planting any trees with the children but there has been no reply.
